GUJARAT PANCHAYATS ACT, 1993.

No. KP/106 of 2014/NTP/102014/69710/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/102/M/PFR/102013/139/L-1, dated the 9th September, 2013 divided the areas of Zalod Taluka into two talukas, namely Zalod Taluka and Sanjeli Taluka;

AND WHEREAS, the areas of the taluka specified in column (4) of the Schedule appended hereto have been excluded from the existing Zalod Taluka and the same have been included in the newly constituted **Sanjeli Taluka**;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a Taluka Panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for **Sanjeli Taluka** is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the **Sanjeli Taluka** Panchayat;
- (ii) reduces interimly the number of members of the existing Zalod Taluka Panchayat from 35 to 27;
- (iii) terminates the Office of the members of the Zalod Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the Zalod Taluka Panchayat, which have been excluded from the said Taluka Panchayat;
- (iv) appoints the same elected members specified in column (2) of the said Schedule to be the members of the **Sanjeli Taluka** Panchayat representing the constituency specified in column (3) falling within the areas of **Sanjeli taluka** shown in column (4) so included in the **Sanjeli Taluka**; and
- (v) declares that the members of Zalod Taluka Panchayat so appointed in the **Sanjeli Taluka** Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the Zalod Taluka Panchayat.
