#### ORDER

Sachivalaya, Gandhinagar, 22<sup>nd</sup> December, 2014.

#### GUJARAT PANCHAYATS ACT, 1993.

No. KP/110 of 2014/NTP/102014/44692/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/98/M/PFR/102013/139/L-1, dated the 9<sup>th</sup> September, 2013 divided the areas of Jasdan Taluka and Sayla Taluka into three talukas, namely Jasdan Taluka, Sayla Taluka and Vinchhiya Taluka;

AND WHEREAS, the areas of the talukas specified in column (4) of the Schedule appended hereto have been excluded from the existing Jasdan Taluka and Sayla Taluka and the same have been included in the newly constituted Vinchhiya Taluka;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a Taluka Panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for Vinchhiya Taluka is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the Vinchhiya Taluka Panchayat;
- (ii) reduces interrimly the number of members of the existing Jasdan Taluka Panchayat from 25 to 14;
- (iii) terminates the Office of the members of the Jasdan Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the Jasdan Taluka Panchayat, which have been excluded from the said Taluka Panchayat;
- (iv) appoints the same elected members specified in column (2) of the said Schedule to be the members of the Vinchhiya Taluka Panchayat representing the constituency specified in column (3) falling within the areas of Vinchhiya taluka shown in column (4) so included in the Vinchhiya Taluka; and
- (v) declares that the members of Jasdan Taluka Panchayat so appointed in the Vinchhiya Taluka Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the Jasdan Taluka Panchayat.
