GUJARAT PANCHAYATS ACT, 1993

No. KP/112 of 2014/NTP/102014/44676/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/84/M/PFR/102013/139/L-1, dated the 9th September, 2013 and Government Notification, Revenue Department. No. GHM/139/ 2014/PFR/102013/139/L-I, Dated 27th November 2014. divided the **Una Taluka** and **Kodinar Taluka** into three talukas, namely **Una taluka**, **Kodinar Taluka** and **Girgadhada taluka**;

AND WHEREAS, the areas of the taluka specified in column (4) of the Schedule appended hereto have been excluded from the existing **Una taluka** and **Kodinar Taluka** and the same have been included in the newly constituted **Girgadhada Taluka**;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a taluka panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879), and therefore, a taluka panchayat for **Girgadhada taluka** is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the **Girgadhada Taluka** Panchayat;
- (ii) reduces interimly the number of members of the existing **Una Taluka** Panchayat from 31 to 18; and **Kodinar Taluka** Panchayat from 21 to 20;
- (iv) terminates the Office of the members of the **Una Taluka** Panchayat **Kodinar Taluka** Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the **Girgadhada Taluka** Panchayat, which have been excluded from the said taluka panchayats;

(v) appoints the same elected members specified in column (2) of the said Schedule to be the members of the **Girgadhada Taluka** Panchayat representing the constituency specified in column (3) falling within the area of **Girgadhada taluka** shown column (4) so included in the **Girgadhada Taluka**;

(vi) declares that the members of **Una Taluka** Panchayat and **Kodinar Taluka** Panchayat so appointed in the **Girgadhada Taluka** Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the **Una Taluka** Panchayat and **Kodinar Taluka** Panchayat respectively.
