GUJARAT PANCHAYATS ACT, 1993.

No. KP/102 of 2014/NTP/102014/64369/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/93/M/PFR/102013/139/L-1, dated the 9th September, 2013 and Government Notification, Revenue Department No. GHM/24/2014/M/PFR/102013/ 139/L-1, Dated 18th February 2014, divided the areas of Mehsana Taluka, Kadi Taluka and Detroj-Rampura into four talukas, namely Mehsana Taluka, Kadi Taluka, Detroj-Rampura and Jotana Taluka.

AND WHEREAS, the areas of the taluka specified in column (4) of the Schedule appended hereto have been excluded from the existing Mehsana Taluka, Kadi Taluka and Detroj-Rampura Taluka and the same have been included in the newly constituted Jotana Taluka;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a taluka panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879); and therefore, a taluka panchayat for Jotana Taluka is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993); the Government of Gujarat hereby,-

- (i) constitutes the Jotana Taluka Panchayat;
- (ii) reduces interimly the number of members of the existing Mehsana Taluka Panchayat from 33 to 29, Kadi Taluka Panchayat from 27 to 25 and Detroj-Rampura Taluka Panchayat From 15 to 14
- (iii) terminates the Office of the members of the Mehsana Taluka Panchayat, Kadi Taluka Panchayat and Detroj-Rampura Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of talukas shown in column (4) of the Mehsana Taluka Panchayat, Kadi Taluka Panchayat and Detroj-Rampura Taluka Panchayat which have been excluded from the said Taluka Panchayats;
