GUJARAT PANCHAYATS ACT, 1993.

No. KP/100 of 2014/NTP/102014/53762/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/86/M/PFR/102013/139/L-1, dated the 9<sup>th</sup> September, 2013 divided the areas of Deesa Taluka, Diyodar Taluka and Tharad Taluka into four talukas, namely Deesa Taluka, Diyodar Taluka, Tharad Taluka, and **Lakhni Taluka**.

AND WHEREAS, the areas of the taluka specified in column (4) of the Schedule appended hereto have been excluded from the existing Deesa Taluka, Diyodar Taluka, and Tharad Taluka and the same have been included in the newly constituted **Lakhni Taluka**;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a taluka panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for **Lakhni Taluka** is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the **Lakhni Taluka** Panchayat;
- (ii) reduces interimly the number of members of the existing Deesa Taluka Panchayat from 37 to 28, Diyodar Taluka Panchayat from 19 to 17 and Tharad Taluka Panchayat from 27 to 24;
- (iii) terminates the Office of the members of the Deesa Taluka Panchayat, Diyodar Taluka Panchayat and Tharad Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the Deesa Taluka Panchayat, Diyodar Taluka Panchayat and **Tharad Taluka** Panchayat, which have been excluded from the said Taluka Panchayats;
- (iv) appoints the same elected members specified in column (2) of the said Schedule to be the members of the **Lakhni Taluka** Panchayat representing the constituency specified in column (3) falling within the areas of **Lakhni Taluka** shown in column (4) so included in the **Lakhni Taluka**; and
- (v) declares that the members of Deesa Taluka Panchayat, Diyodar Taluka Panchayat and Tharad Taluka Panchayat so appointed in the **Lakhni Taluka** Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the Deesa Taluka Panchayat, Diyodar Taluka Panchayat and **Tharad Taluka** Panchayat respectively.
