#### ORDER

Sachivalaya, Gandhinagar, 23<sup>rd</sup> December, 2014.

#### GUJARAT PANCHAYATS ACT, 1993.

No. KP/114 of 2014/NTP/102014/639172/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/100/M/PFR/102013/139/L-1, dated the 9<sup>th</sup> September, 2013 divided the areas of Sankheda Taluka, Jetpur-pavi Taluka, into three talukas, namely Sankheda Taluka, Jetpur-pavi Taluka, and Bodeli Taluka.

AND WHEREAS, the areas of the taluka specified in column (4) of the Schedule appended hereto have been excluded from the existing Sankheda Taluka, Jetpur-pavi Taluka and the same have been included in the newly constituted Bodeli Taluka;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a taluka panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for Bodeli Taluka is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the Bodeli Taluka Panchayat;
- (ii) reduces interimly the number of members of the existing Sankheda Taluka Panchayat from 23 to 12, Jetpur-pavi Taluka Panchayat from 27 to 17;
- (iii) terminates the Office of the members of the Sankheda Taluka Panchayat and Jetpur-pavi Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the Sankheda Taluka Panchayat and Jetpur-pavi Taluka Panchayat, which have been excluded from the said Taluka Panchayats;
