CONSTITUTION OF INDIA.

NO : GP/24/of/2013/PRX/102013/1149/Z :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Gujarat Development Service Department Examination Rules, 1990, namely :-

- (1) These rules may be called the Gujarat Development Service Department Examination (Amendment) Rules, 2013.
- (2) In the Gujarat Development Service Departmental Examination Rules, 1990 (hereinafter referred to as "the said rules"), in rule 4, in the second proviso, for the words "completed four years' continuous service", the words "been appointed on regular basis in" shall be substituted.
- (3) In the said rules, for rule 10, the following rule shall be substituted, namely:-
"10. Syllabus and type of the Examination.

The syllabus for the examination shall be as specified in Appendix-A. The examination shall be of objective type having multiple choice questions."
