GUJARAT PANCHAYATS ACT, 1993.

No. KP/ 73 of 2014/NTP/102014/53766/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/95/M/PFR/102013/139/L-1, dated the 9th September, 2013 divided the areas of Vav Taluka into two talukas, namely Vav Taluka and **Suigam Taluka**;

AND WHEREAS, the areas of the taluka specified in column (4) of the Schedule appended hereto have been excluded from the existing Vav Taluka and the same have been included in the newly constituted Suigam Taluka;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a Taluka Panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for **Suigam Taluka** is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the **Suigam Taluka** Panchayat;
- (ii) reduces interimly the number of members of the existing Vav Taluka Panchayat from 23 to 14;
- (iii) terminates the Office of the members of the Vav Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the Vav Taluka Panchayat, which have been excluded from the said Taluka Panchayat;

- (iv) appoints the same elected members of the said Taluka Panchayat as if they were members of the said Taluka Panchayat;

- (v) declares that the members of Vav Taluka Panchayat so appointed in the **Suigam Taluka** Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the Vav Taluka Panchayat.
