GUJARAT PANCHAYATS ACT, 1993.

No. KP/75 of 2014/NTP/102014/44685/J:-WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/91/M/PFR/102013/139/L-1, dated the 9<sup>th</sup> September, 2013 divided the areas of Pardi Taluka into two talukas, namely Pardi Taluka and Vapi Taluka;

AND WHEREAS, the areas of the taluka specified in colum (4) of the Schedule appended hereto have been excluded from the existing Pardi Taluka and the same have been included in the newly constituted Vapi Taluka;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a Taluka Panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for Vapi Taluka is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the **Vapi Taluka** Panchayat;
- (ii) reduces interimly the number of members of the existing Pardi Taluka Panchayat from 27 to 17;
- (iii) terminates the Office of the members of the Pardi Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the Pardi Taluka which have been excluded from the said Taluka Panchayats;

- (v) declares that the members of Pardi Taluka Panchayat so appointed in the Vapi Taluka Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the Pardi Taluka Panchayat.
