#### GUJARAT PANCHAYATS ACT, 1993.

No. KP/77 of 2014/NTP/102014/610771/J:-WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2014/45/PFR/102013/139/L-1, dated the 18<sup>th</sup> February, 2014 divided the areas of Nandod Taluka into two talukas, namely Nandod Taluka and **Garudeshwar Taluka**;

AND WHEREAS, the areas of the taluka specified in column (4) of the Schedule appended hereto have been excluded from the existing Nandod Taluka and the same have been included in the newly constituted **Garudeshwar Taluka**;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a Taluka Panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for **Garudeshwar Taluka** is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the **Garudeshwar Taluka** Panchayat;
- (ii) reduces interimly the number of members of the existing Nandod Taluka Panchayat from 23 to 13;
- (iii) terminates the Office of the members of the Nandod Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the Nandod Taluka which have been excluded from the said Taluka Panchayats;

- (iv) appoints the same elected members specified in column (2) of the said Schedule to be the members of the **Garudeshwar Taluka** Panchayat representing the constituency specified in column (3) falling within the areas of **Garudeshwar Taluka** shown in column (4) so included in the **Garudeshwar Taluka**; and
- (v) declares that the members of Nandod Taluka Panchayat so appointed in the **Garudeshwar Taluka** Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the Nandod Taluka Panchayat.
