GUJARAT PANCHAYATS ACT, 1993.

No. KP/79 of 2014/NTP/102014/610760/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/96/M/PFR/102013/139/L-1, dated the 9th September, 2013 divided the areas of Chotila Taluka, Muli Taluka and Sayla Taluka into four talukas, namely Chotila Taluka, Muli Taluka, Sayla Taluka and **Thangadh** Taluka;

AND WHEREAS, the areas of the talukas specified in column (4) of the Schedule appended hereto have been excluded from the existing Chotila Taluka, Muli Taluka and Sayla Taluka and the same have been included in the newly constituted **Thangadh** Taluka;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a taluka panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for **Thangadh** Taluka is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the **Thangadh** Taluka Panchayat;
- (ii) reduces interrimly the number of members of the existing Chotila Taluka Panchayat from 17 to 13.
- (iii) terminates the Office of the members of the Chotila Taluka Panchayat, specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the Chotila Taluka Panchayat, which have been excluded from the said Taluka Panchayat;
- (iv) appoints the same elected members specified in column (2) of the said Schedule to be the members of the **Thangadh** Taluka Panchayat representing the constituency specified in column (3) falling within the areas of **Thangadh** taluka shown in column (4) so included in the **Thangadh** Taluka: and

(v) declares that the members of Chotila Taluka Panchayat so appointed in the **Thangadh** Taluka Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the Chotila Taluka Panchayat.
