GUJARAT PANCHAYATS ACT, 1993.

No. KP/81 of 2014/NTP/102014/625305/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/99/M/PFR/102013/139/L-1, dated the 9th September, 2013 divided the areas of Thasra Taluka into two talukas, namely Thasra Taluka and **Galteshwar Taluka**;

AND WHEREAS, the areas of the taluka specified in column (4) of the Schedule appended hereto have been excluded from the existing Thasra Taluka and the same have been included in the newly constituted **Galteshwar Taluka**;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a Taluka Panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for **Galteshwar Taluka** is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the **Galteshwar Taluka** Panchayat;
- (ii) reduces interrimly the number of members of the existing Thasra Taluka Panchayat from 29 to 17;
- (iii) terminates the Office of the members of the Thasra Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the Thasra Taluka which have been excluded from the said Taluka Panchayats;
- (iv) appoints the same elected members specified in column (2) of the said Schedule to be the members of the **Galteshwar Taluka** Panchayat representing the constituency specified in column (3) falling within the areas of **Galteshwar taluka** shown in column (4) so included in the **Galteshwar Taluka**; and

(v) declares that the members of Thasra Taluka Panchayat so appointed in the **Galteshwar Taluka** Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the Thasra Taluka Panchayat.
