#### GUJARAT PANCHAYATS ACT, 1993.

No. KP/83 of 2014/NTP/102014/44682/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/97/M/PFR/102013/139/L-1, dated the 9<sup>th</sup> September, 2013 divided the areas of **Barvala** and **Dhandhuka** Talukas into three talukas, namely **Barvala** Taluka, **Dhandhuka** Taluka and **Dholera** Taluka;

AND WHEREAS, the areas of the taluka specified in colum (4) of the Schedule appended hereto have been excluded from the existing **Barvala** Taluka and **Dhandhuka** Taluka and the same have been included in the newly constituted **Dholera** Taluka;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a Taluka Panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for **Dholera** Taluka is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

(i) constitutes the **Dholera Taluka** Panchayat;

(ii) reduces interimly the number of members of the existing **Barvala** Taluka Panchayat from 15 to 12, and **Dhandhuka** Taluka Panchayat from 17 to 11;

(iii) terminates the Office of the members of the **Barvala** Taluka Panchayat and **Dhandhuka** Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the **Barvala** Taluka Panchayat and **Dhandhuka** Taluka Panchayat, which have been excluded from the said Taluka Panchayats;

(iv) appoints the same elected members specified in column (2) of the said Schedule to be the members of the **Dholera** Taluka Panchayat representing the constituency specified in column (3) falling within the areas of **Dholera** Taluka shown in column (4) so included in the **Dholera** Taluka; and

(v) declares that the members of Barvala Taluka Panchayat and Dhandhuka Taluka Panchayat so appointed in the Dholera Taluka Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the Barvala Taluka Panchayat and Dhandhuka Taluka Panchayat respectively.
