GUJARAT PANCHAYATS ACT, 1993.

No. KP/85 of 2014/NTP/102014/428177/J:- WHEREAS the Government of Gujarat by Government Notification, Revenue Department No. GHM/2013/104/M/PFR/102013/139/L-1, dated the 9th September, 2013 divided the areas of Savli Taluka into two talukas, namely Savli Taluka and Desar Taluka;

AND WHEREAS, the areas of the taluka specified in column (4) of the Schedule appended hereto have been excluded from the existing Savli Taluka and the same have been included in the newly constituted Desar Taluka;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 provides that there shall be a Taluka Panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for Desar Taluka is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby,-

- (i) constitutes the **Desar Taluka** Panchayat;
- (ii) reduces interimly the number of members of the existing Savli Taluka Panchayat from 25 to 17;
- (iii) terminates the Office of the members of the Savli Taluka Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the Savli Taluka Panchayat, which have been excluded from the said Taluka Panchayat;
- (iv) appoints the same elected members specified in column (2) of the said Schedule to be the members of the Desar Taluka Panchayat representing the constituency specified in column (3) falling within the areas of Desar taluka shown in column (4) so included in the Desar Taluka; and

(v) declares that the members of Savli Taluka Panchayat so appointed in the Desar Taluka Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the Savli Taluka Panchayat.
