GUJARAT PANCHAYATS, ACT, 1993.

No. KP/26 of 2017/NTP/102017/420727/J:- WHEREAS the Government of Gujarat in exercise of the powers conferred by section 7 of the Gujarat Land Revenue Code, 1879 (Bom.V of 1879) under Government Notification, Revenue Department No. GHM/2017/19/M/PFR/372016/941/L-1, dated the 3rd April, 2017 divided the areas of **Limkheda Taluka** into two talukas, namely **Limkheda Taluka** and **Singvad Taluka**;

AND WHEREAS, the areas of the taluka specified in column (4) of the Schedule appended hereto have been excluded from the existing **Limkheda Taluka** and the same have been included in the newly constituted **Singvad Taluka**;

AND WHEREAS, section 3 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993) provides that there shall be a Taluka Panchayat for each taluka constituted from time to time under the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) and therefore, a taluka panchayat for **Singvad Taluka** is required to be constituted;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 264 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby:-

- (i) constitutes the **Singvad Taluka** Panchayat;
- (ii) reduces interimly the number of members of the existing **Limkheda Taluka** Panchayat from **34** to **21**;
- (iii) terminates the Office of the members of the **Limkheda Taluka** Panchayat specified in column (2) of the Schedule appended hereto representing the constituency specified in column (3) falling within the areas of taluka shown in column (4) of the **Limkheda Taluka** which have been excluded from the said Taluka Panchayat;

- (iv) appoints the same elected members specified in column (2) of the said Schedule to be the members of the **Singvad Taluka** Panchayat representing the constituency specified in column (3) falling within the areas of **Singvad taluka** shown in column (4) so included in the **Singvad Taluka**; and
- (v) declares that the members of **Limkheda Taluka** Panchayat so appointed in the **Singvad Taluka** Panchayat shall hold office for a term which shall be co-extensive with the remaining term of the **Limkheda Taluka** Panchayat.
