No.GP/13 of 2016/BHARAT/102012/2380/Z:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of the Gujarat hereby makes the following rules further to amend the Taluka Development Officer, (Gujarat Development Service, Class-II) Recruitment Rules, 1990, namely:-

1. These rules may be called the Taluka Development Officer, (Gujarat Development Service, Class-II) Recruitment (Amendment) Rules, 2016.

2. In the Taluka Development Officer, (Gujarat Development Service, Class-II) Recruitment Rules, 1990 (hereinafter referred to as “the said rules”), for rule 3, the following shall be substituted, namely :-

“3. The appointment by promotion and by direct selection shall be made in the ratio of 2:1.”

3. In the said rules, in rule 4, in clause(a), for the figures and words “21 years” and “28 years”, the figures and the words “20 years” and “35 years” shall be substituted, respectively.

4. In the said rules, in the Schedule,-

(i) for part (A), the following shall be substituted, namely:-

“(A) Cadres of Panchayats Services:

1. Deputy Taluka Development Officer,
2. Deputy Chitnis,
3. Taluka Panchayat Officer,
4. Extension Officer (Panchayats),
5. Extension Officer (Agriculture), Grade-II,
6. Extension Officer (Co-operation).

(ii) in part (B), in the entry at Sr. No.2, for the words “Aval Karkuns”, the words “Deputy Chitnis” shall be substituted.
