**Order**

Whereas, the term of the present Assembly expires in January 2018, the General Election to Gujarat Legislative Assembly will be held before January-2018. As a part of preparatory activities of the ensuing General Election to the Legislative Assembly, data base of all the employees eligible for the posting on election duties is being prepared.

And whereas, as per Section 159 of the Representation of people Act, 1951 following authorities when so requested by Chief Electoral Officer are required to make available to any Returning Officer such staff as may be necessary for the performance of any duties in connection with an election:-

- 1) Every Local Authority;
- 2) Every University established or incorporated by or under a Central, Provincial or State Act;
- 3) A Government Company as defined in Section 617 of the Companies Act, 1956;
- 4) Any other institution, concern or undertaking which is established by or under a Central, Provincial or State Act or which is controlled, or financed wholly or substantially by funds provided, directly or indirectly, by the Central Government or a State Government.

Whereas, the District Election Officers appointed by the Election Commission of India under Section 13AA of the Representation of the People Act, 1950 are responsible under section 20A of the Representation of People Act, 1951 to perform any function entrusted by the Chief Electoral Officer. Accordingly, all the District Election Officers are being instructed to collect the information from the Central/State Government offices as well as offices falling under Section 159(2) of the Representation of People Act, 1951 regarding staff available in their offices for performance of various duties in connection with the General Election to Gujarat Legislative Assembly.

Your organization is one of the authorities covered under Section 159(2) of the Representation of People Act, 1951. Therefore, I, the Chief Electoral Officer, Gujarat State, in exercise of powers conferred under
